### Florida: Suzanne J. Violet Retires as Delegate for the CSA



Suzanne has served as a delegate for the Council of the Swiss Abroad (CSA) since 1994. She was elected to the Executive Board as the first woman and held the first seat representing Swiss living overseas that same year. All the other Board members were from Europe. She served as Vice President of the Executive Board from 2013 to 2017. In the 23 years that she represented us Swiss living abroad, she has

been engaged in many very important issues. Following are a couple of examples of her involvement in her own words:

"I remember several big issues where I was contacted by Swiss citizens living in the United States and consequently took their problems, thoughts, and issues to Bern and told the Council and the Executive Board these stories."

"We were fighting for keeping the voluntary AHV/IV for the Swiss living abroad. I had contacted Swiss Clubs in my district in the South East of the United States and asked the presidents to ask around among the members of their Swiss Clubs if somebody would be impacted if it got cancelled. Several women came forward. I spoke with them personally and asked them to write me a letter about their case. Then I took the letters to the Executive Board meeting. We were collecting letters from all over the world and did not give up. Finally, Bundesrätin Ruth Dreifuss agreed that the Swiss living overseas could continue to pay voluntary into the AHV/IV under certain conditions. The Swiss living in Europe no longer have this opportunity."

"Questions how to vote came up occasionally and then about 13 years ago when Swiss banks were closing bank accounts of Swiss citizens living abroad especially in the US, the phone kept ringing and ringing. And again, at every Executive Board meeting I was reporting what I heard from my compatriots. It was an ongoing issue and we

kept pushing and pushing the Swiss government to take action. It looks like that there is finally a solution coming in the near future."

Suzanne was born and raised in Switzerland. After a successful career in Switzerland and extensive traveling around the world visiting all five continents, she decided to settle in Cocoa Beach, Florida. There, she started her first company, The Swiss Link Inc., an international consulting firm that concentrated in the export of American goods to Europe in addition to construction, interior decorating, and remodeling. Subsequently, Suzanne founded her brokerage firm S. Violet International Business Brokers which specializes in selling business investments. Understanding the importance of listening to her clients' needs as well as the magnitude of the confidentiality involved, Suzanne focuses on finding each of her clients the right business and guides them through the whole purchasing process. From 2007 to 2017, she was also the general manager of a local boutique hotel with six clay tennis courts that needed remodeling.

As a member of the Cocoa Rotary since 1992, Suzanne has volunteered for many community events. She was a member of the Space Coast Tiger Bay Club and was among the founders of the Swiss American Chamber of Commerce, Florida Chapter. She was a board member of the Healthy Start Coalition of Brevard and its president for one term. In 2002 Suzanne was the president of the Florida Business Brokers Association, Central Florida Chapter and a member of the State Board. Suzanne served for 10 years on the board of her condo association in various functions to build up the neighborhood after a management company had run it into the ground. For four years she was the president of the Swiss Club of Central Florida.

We thank Suzanne for all her efforts on our behalf and wish her a well deserved "retirement" from one position while she's continuing to concentrate her efforts on her business at S. Violet International Business Brokers ([www.svioletinternational.com](http://www.svioletinternational.com)).

**Fifth Switzerland: OSA and CSA Responsibilities**

Ten percent of all Swiss nationals live outside Switzerland (Fifth Switzerland).

Connecting the five Switzerlands is the mission of the Organisation of the Swiss Abroad (OSA) information and communication department. Using effective communication means, the department is in direct contact with the large public of the Fifth Switzerland, the official Swiss representations abroad, the various Swiss clubs and societies throughout the world, as well as the Swiss media and the members of the Swiss Parliament.

Serving the interests of the community of the Swiss Abroad is of utmost importance. It is the Council of the Swiss Abroad (CSA), supreme organ of the OSA, which assumes this task. The CSA is largely composed of delegates chosen from among the Swiss Abroad. The Swiss federal authorities recognize the CSA as the official voice of the "Fifth Switzerland". Thanks to the parliamentary group of the Swiss Abroad, which comprises almost 100 parliamentarians, the OSA has a direct link to the Swiss federal parliament. The greatest achievements of the CSA include the implementation of the Swiss Abroad Act and the introduction of postal voting for the Swiss Abroad. The OSA is currently engaged in political lobbying to introduce e-voting for the Swiss Abroad. The OSA also encourages its fellow citizens abroad to register to vote so that they can participate in political debates and have a voice in Switzerland.

## Florida: Swiss American Club of Miami

September 4th, 2017 – everyone started to prepare for hurricane Irma: stocking up on food, batteries, water, etc.

September 5th – Miami Dade county announced that Irma is a category 5 storm moving in the direction of South Florida and listed the areas which had to evacuate. Our neighbors who have been living here for many years decided to stay, however, some had hotel room reservation close to the airport of Miami just in case. We put everything that could fly away inside. We waited in line at the gas stations which had still gas left with the police controlling the situation. Traffic was horrible, and everyone started to get anxious.

September 6th – more preparing and shopping. In the evening the Swiss American Club had their monthly “Stammtisch”. Plans on how to survive were shared: some wanted to leave but had no gas; one



person could not get a car rented; one board member had decided to stay. A lot of people were leaving and at one stage I asked myself the same thing, but we decided to stay because we

are in an elevated zone and a Hospital is in walking distance.

September 7th – we saw that the eye of the storm moved west which was a relief, but Miami Dade informed that zones A, B and C still had to evacuate. More people left by car, plane or moved into a hotel. By now no more hotel rooms were available in the greater Miami area.

September 8th – “die Ruhe vor dem Sturm” (the calm before the storm). Everything was closed because everyone was getting ready or had left, except for the Hospital ER which was packed with people who got hurt preparing their houses for the storm.

September 9th – our area experienced a pre-storm at 5:00 am; one branch of a tree fell on a car close to us. At this stage we bonded with our neighbors and we shared time, food and drinks.

September 10th – at 9:00 am the real storm started with wind and gusts up to 96 mph in our area; some parts of the city like Brickell were



flooded. At 11:20 am power was out and at 4:00 pm we left the house for a quick check on the damage. Trees had fallen everywhere, and it felt so spooky with debris left and right. There were

warnings on the radio to stay inside because of tornados and gusts.

September 11th – 9:00 am we started cleaning up. We got electricity back at 10:30 am thanks to the Hospital nearby.




There was a curfew every night until September 13th. The scary part was not being able to leave for any emergencies. No traffic was possible. We always had telephone and internet connection, but some people did not. Boredom started and the Jass cards were a blessing!

We called the elderly members of the Swiss Club in Miami to find out if they were ok. We found out that Karl Ochsendorf who came to the US in 1956 and has been a Swiss Club member for over 60 years was put in the hospital on September 12th. His breathing was labored due to water in his lungs, and the hot weather conditions inside his house (no A/C) made it worse. He was very happy to see Astrid Artho and myself at the hospital. His daughter-in-law had been looking after Loti and Karl and stayed with them during the hurricane.
