## Swiss Abroad Congress:

# Strengthening global connections and representation

On March 15, 2024, the Spring session of the Congress of the Swiss Abroad in Bern saw notable attendance from UK Delegates Loredana Guetg Wyatt, Franz Muheim, Lakshmi Sundaram, and Andrea Feller-Ryf. OSA President Filippo Lombardi discussed recent elections favouring the 13th pension. He emphasized the importance of maintaining a positive image for Swiss abroad, highlighting their global influence and contributions.

Madame Estelle Revaz, Geneva SP National Councillor, a professional cellist, joined the OSA council. An informative

session with the Department of Foreign Affairs discussed budget cuts necessitated by recent expenditures. Initiatives targeting different demographics of Swiss expatriates were discussed, including support for the ageing population and aiding transitions between working abroad and returning to Switzerland.

The importance of utilizing tools like the TravelAdmin and SwissInTouch apps was highlighted by Mr. Michele Malizia. Vision 2035 aims to outline budgetary priorities for the next decade. The OSA's working groups presented their initiatives. The group run by

Andreas Feller-Ryf on direct voting of OSA representatives collaborates with the DFAE. President Lombardi reassured OSA delegates are voted in democratically with room for improvement. Delegate Franz Muheim reminded participants to ensure candidates are enrolled in the electoral role.

The working group on Swiss representation at the National Council, led by former UK delegate Vincent Croiset, presented findings. Despite Article 8 promising equality, challenges persist in fair representation for Swiss abroad. The group advocates for models seen in France, Italy, and Portugal.

Loredana Guetg-Wyatt and Lakshmi Sundaram presented FOSSUK, discussing challenges in supporting Swiss citizens abroad. In conclusion, the Spring session of the Congress of the Swiss highlighted ongoing efforts to strengthen the representation and support of Swiss citizens living abroad.

**New OSA delegates elections:** Exploring new electoral paths and community engagement

At the recent OSA congress, discussions were raised regarding a significant shift in the electoral process for OSA delegates. The election of new UK representatives at the Parliament of the Swiss Abroad will be held next year in Springtime. Currently, in the UK there is a hybrid solution whereby three delegates are directly elected and two are voted in by the corporate members of FOSSUK. The latter must be equal members of a Swiss club in the UK that pays membership fees to FOSSUK to be voted. This is a system challenged by several key issues.

Primarily, Swiss clubs grapple with recruitment hurdles and the scarcity of members willing to pursue candidacy. This procedure raises concerns among diverse demographics, particularly the youth, advocating for more inclusive participation in the vote. Additionally, as Swiss clubs in the UK diminish in number as they struggle to recruit new members, doubts arise regarding the usefulness of leaving such a significant voting authority within these entities. In light of these discussions, we turn to **Loredana Guetg-Wyatt** – a UK delegate at OSA twice, currently holds the position of FOSSUK president for the second time and previous president of the Swiss club New Helvetic Society – for insights into the implications and potential transformations looming over the electoral landscape.

*SR: At the last congress, there was a discussion about the possibility of direct elections for the representatives of the UK at the OSA Parliament. What's your perspective on this proposal? How do you think direct elections would impact representation and engagement among Swiss expatriates in the UK?*

**LGW:** My perspective is that it is time to reconsider and discuss how the elections of UK delegates are conducted and whether the current procedures reflect the changes in the Swiss demographic in this country. I am in favour of direct elections of the UK delegates. However, this decision needs to be deliberated and approved by the majority of the

corporate members belonging to FOSSUK. Urgently, we need to assess whether the current election model aligns with the evolving demographic of Swiss residents in the UK. Clubs are struggling to attract new members and moreover, those that join, may only stay for a year or two, therefore limiting opportunities for new candidates to emerge. Furthermore, the number of Swiss clubs in the country has significantly declined in recent years, leaving a small group to represent the needs of FOSSUK and thus of the Swiss abroad in the United Kingdom. Can we realistically expect only a few representatives to adequately represent the entire voting community? While Swiss people still desire to gather and celebrate their roots and culture, there is a shift in how they prefer to do so. It seems that traditional clubs, as they are currently structured, are not the most effective means of bringing people together, especially for young individuals. We should voice this need and work together to explore the most effective ways to facilitate community gatherings and cultural celebrations.

## 100<sup>th</sup> Congress of the Swiss Abroad: Celebrations in Brunnen with the expat community and emerging artists

The beautiful ‘Place of the Swiss Abroad’ in Brunnen belongs to the over 800,000 Swiss living abroad and symbolizes their connection with their home country. The place marks the final section of the ‘Swiss path,’ a hiking path around Lake Uri, where every canton is represented by a stretch of the track, established for the 700<sup>th</sup> anniversary of the Swiss Confederation in 1991.

The foundation ‘Auslandschweizerplatz Brunnen’ is the owner of the place. The federal government, the Canton Schwyz, the community of Ingenbohl-Brunnen, the Schwyzer Kantonbank, as well as the Organisation of the Swiss Abroad (OSA), all provide members to the foundation board. If you get a chance to visit Brunnen, the ‘Place of the Swiss Abroad’ on the shore of Lake Lucerne (the lake of the four cantons) is well worth visiting, with a beautiful view over the lake, the Rütli, which is the birthplace of Switzerland, and the mountains in central Switzerland.

At the Swiss Abroad Congress in St. Gallen in August 2023, the foundation launched the third ‘artist in residence’ project, aiming to facilitate contact between Swiss Abroad artists and local Swiss residents. This time, the call was made for a wide variety of art forms, and young Swiss artists living abroad were strongly encouraged to apply. The award for the winning Swiss artist living abroad is a stipend to work in Brunnen using local facilities such as an atelier, an art gallery, or equivalent. Their stay could also feature events, e.g., at the ‘Place of the Swiss Abroad’.

The jury, comprising Norbert Mettler (chair and former vice-president of the foundation), Silvia Schranz (president of Kultur Brunnen), Alex Hauenstein (president of the foundation), David



Clavadetscher (director of Spettacolo), and Alvaro Schoeck (regisseur), chose Nat Cartier – a performance artist, producer, and songwriter living in Edinburgh – from the field of applicants as the winner of the stipend award. Nat is already a well-known musician in the United Kingdom with successful projects to his name. He is underway in several modern genres of music, which he calls Neo.

The 100<sup>th</sup> congress of the OSA will take place in Lucerne from the 11<sup>th</sup> to the 13<sup>th</sup> of July. There will be a boat trip from Lucerne to Brunnen where delegates will have the opportunity to meet on the square dedicated to the Swiss abroad. A vernissage will take place in Brunnen in conjunction with the 100<sup>th</sup> Congress. For this occasion, OSA has launched a new campaign aimed at raising funds for the organisation. ### ‘Artists in residence’ project: Blending Swiss traditions with artistic pursuits

Nat Cartier, the musician and songwriter selected for the ‘Artist in Residence’ project, discusses his upcoming residency in Brunnen, aiming to blend Swiss traditions with his art.

*SR: Can you share your background as a performer, producer, and songwriter, and how it influenced your decision to apply for the residency?*

NC: I began piano and saxophone at age 5, later joining Swiss youth orchestras. High school marked my song writing debut, flourishing

in Edinburgh. Identifying as Swiss significantly shaped my career, inspiring my application. Emigrating while maintaining a connection fuelled my aspiration for international success.

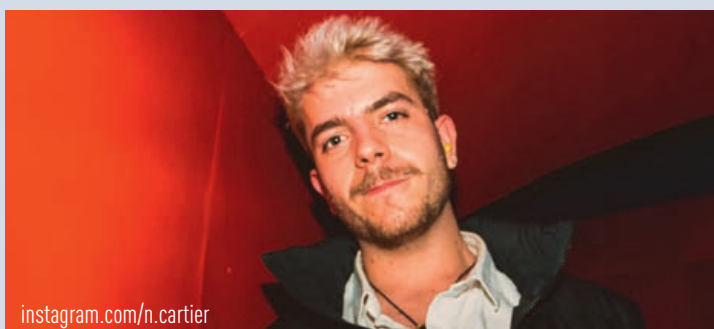
*SR: How will you spend your time in Brunnen and weave Swiss experiences into your art?*

NC: I’ll immerse in creation during the five-week residency from July 10<sup>th</sup> to August 18 – networking and collaborating with local artists. Infusing Swiss traditional music, even with a yodel club, I’ll channel Brunnen’s essence through painting, photography, and poetry.

*SR: With your diverse background and aim to collaborate with Swiss artists, are there themes you’re excited to explore?*

NC: I’m eager to develop ‘Neo’ music, an organic, narrative-driven genre. I’ll integrate painting, photography, and poetry, inspired by Brunnen’s canals. The challenge lies in seamlessly intertwining these elements, infusing Swiss traditions. The absence of genre requirements offers room for creative exploration and community engagement.

## Exploring emigration and womanhood: The Unione Ticinese's 150<sup>th</sup>-anniversary play takes the stage

Unione Ticinese (UT), a historic Swiss society in London marking its 150<sup>th</sup> anniversary, is commissioning a new play (see issue 2/2024). Written, produced, and performed by Swiss Italian artists based in London and Ticino, the production explores emigration and womanhood themes, fostering connections between Swiss and international communities. Selected from 11 submissions in an open call competition, 'Valchera's' by *Lea Ferrari* (Ticino) won the commission. Inspired by her great-grandparents' migration from Ticino to Paris, Ferrari delves into the female perspective of emigration, addressing timeless struggles and existential questions. Initially in Italian with an English translation, the play features London-based Ticinese actors *Martina Greenwood* and *Nabila Dolfini*, who we interview, performing in the play and looking after the production. The play is directed by *Alan Alpenfelt*, with dramaturg *Matteo Luoni*. A partnership with The Cockpit Theatre in London sees the production staged in October, right after the 'Settimana della Lingua Italiana nel Mondo'. Plans include performances in Ticino, London, and other Swiss cities.

*SR: What motivated you to choose the themes of emigration and womanhood for this play, and how do you envision these themes resonating with the audience?*

**Nabila and Martina:** The intention with our callout was to reflect on emigration, inviting playwrights to explore it however they wished: through a story based on historical facts or a completely fictional, personal, magical, based on folklore, or utopian world – and we were met with extraordinary proposals. We loved 'Valchera's' because it presented a singular view on emigration seen from the perspective of women whilst offering a window into a unique corner of Switzerland. Lea cleverly weaves several themes into the play; we hope the audience will find more than one answer and, hopefully, more questions will arise.

*SR: As actors, what unique perspectives or insights do you bring to portraying the characters in 'Valchera's,' especially considering the historical and cultural context of emigration from Ticino?*

**Nabila:** Emigrating over 100 years ago was a completely different experience than mine, and the character of Iride will need to flourish through a thorough understanding and physical embodiment of those times as much as my indelible Ticinese essence.

**Martina:** I'm finding those elements that are similar between myself, Tina, and my friendship with Nabila/Iride – there's a parallel real-life story happening as we create this play that I think will enrich 'Valchera's' even more. And I welcome and throw myself into all that is different, which will no doubt stretch me in more than one direction.

*SR: How do you see this production contributing to the broader goals of strengthening connections between the Italian-speaking region of Switzerland, its artists, and the international community in London?*

**Nabila and Martina:** 'Valchera's' tells a unique and untold story about the often unknown Italian-speaking region of Switzerland. We want to offer a reflection on emigration, illustrating how this universal phenomenon influences society and how it impacts individuals. Often, understanding ourselves comes from understanding others. Sharing this project with an international audience could be an enriching reflection towards our roots, our ancestors, and future generations.

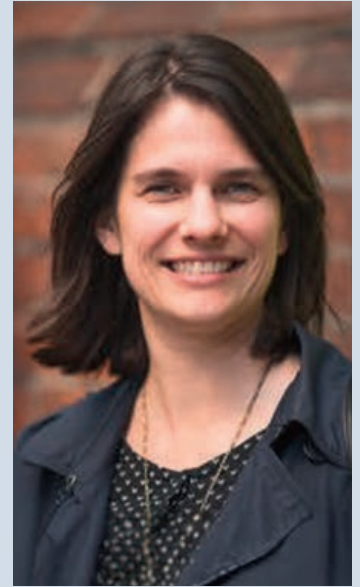
transformation, blending its 250-year-old architectural splendour with a modernist aesthetic to create a captivating space serving as both a sanctuary and an arts hub.

## The UK ETA is coming: What Swiss citizens need to know

The UK has launched its new Electronic Travel Authorisation (ETA) scheme, starting with the Gulf States and Jordan. The scheme is set to be extended to include all those who do not currently need a visa to visit or transit through the UK. There will be plenty of announcements from the Home Office and the airlines ahead of the introduction of the scheme to European countries, including Switzerland, possibly in the second half of 2024.

### What can Swiss citizens in the UK do to get ready?

- + If you hold **settled or pre-settled status** under the EU Settlement Scheme, keep your UK Visa and Immigration account ([gov.uk/update-uk-visas-immigration-account-details](https://gov.uk/update-uk-visas-immigration-account-details)) up to date and upload all your valid Swiss identity documents that you use for travel. This will be particularly important for travelling to the UK once the ETA scheme applies to Swiss citizens too.
- + If you currently hold **Indefinite Leave to Enter or Remain (ILR)** status obtained before Brexit please see Question 9 in the Embassy's Brexit FAQ ([eda.admin.ch/london/brexit](https://eda.admin.ch/london/brexit)) for information on what you can do to have your immigration status electronically recorded, for example by applying for a Biometric Residence Permit.
- + If you are a **Swiss-UK dual citizen**, you are advised to enter the UK on a British passport.

In May, the Finta Music Exchange programme supports three women – inter and non-binary music artists – to take their first steps towards the UK.

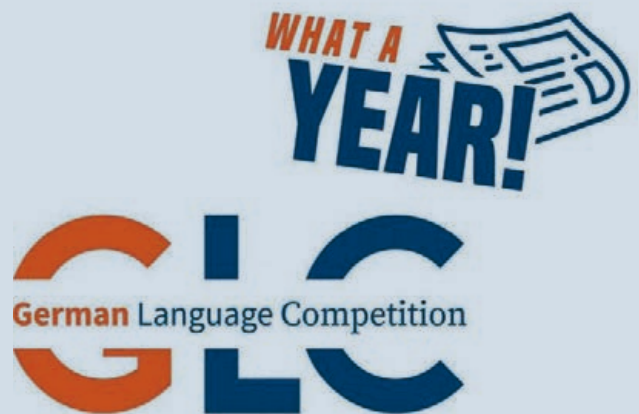
